## **GENERAL TERMS AND CONDITIONS**

1. Tenders are invited for : Annual term contract for Repairing Cantt Dispensary building. The estimated cost indicated against the works is approximate and the tenderer will have no claim against the Cantonment Board if the actual cost of the work increases or decreases. The work will be carried out in accordance with the specification describe in MES SSR 2009 (part-I) and Military Engineer Services Standard Schedule of Rates 2010 (Part-II) as amended up to date. Contractors / tenderer should quote their rates in Financial Bid
2. E-bids shall be submitted in two bid system as follows:-
  - a) Technical e-bid
  - b) Financial e-bid
3. (i) The Bidder shall be bound by all rules and regulations fixed by the Board and any violation may invite forfeiture of his earnest money.  
(ii) No conditional tenders will be accepted.
4. Each bidder fulfilling the following criteria and submitting following documents attested copies in technical bid will be eligible to participate in financial bid:
  - a) Registered as civil contractors with MES / CPWD / PWD / RAILWAYS or any other Govt. deptt. / local body. Registered as civil contractor in Cantonment Board Pachmarhi.
  - b) PAN card
  - c) Bank solvency
  - d) Two years Income Tax returns(i.e for FY 2015-16 and 2016-17)
  - e) Certificate of Chartered Accountant regarding turnover should not be less than of 03 Lakhs per annum from business of civil works two financial year.(i.e. for FY2015-16 and 2016-17)
  - f) Proof of payment of tender fee
  - g) Proof of payment of EMD
  - h) Duly signed copy of tender document.
5. Tender document indicating full details of the tender is available at portal address [www.eprocure.gov.in](http://www.eprocure.gov.in) and shall be submitted through e-tendering portal only. The -bids will not be accepted in any other form. Bidder are advised to get themselves acquainted with the requirement for e-tendering at portal mentioned above. Clarification needed, if any may be obtained from the office on any working day from Engineering Branch, Cantonment Board Pachmarhi.
6. Cost of tender form is to be paid through Demand Draft. in favour of Chief Executive Officer, Cantt Board, payable at Pachmarhi. Non-submission of Demand draft for tender fee shall lead to disqualification.
